### **Gun Show Rules Reminder**

Our March Gun Show was well attended and vendors seemed pleased. The Show Host and crew and the volunteers worked very hard to make the show a success. Most vendors at our shows comply with the rules stated on the back of the Gun Show application form. However, there are reoccurring problems that the NMGCA as an organization must address and solve. The following are critical issues:

- 1. Vendors moving tables. The tables are set up to provide adequate aisle spacing for vendors as well as to meet the Fire Marshall's requirements. Please respect the safety rules and be considerate of your fellow vendors. Non compliance can result in the Gun Show being shut down.
- 2. Vendors leaving through doors not authorized during show hours. Certain doors are manned during hours that the Gun Show is open. These are the doors that should be used for entry and exit. Exiting through doors that do not have security jeopardizes your merchandise and the merchandise of other vendors. Please comply with these rules to help minimize the potential for loss due to theft.
- 3. Vendors leaving early. Show Rule number 14 states: "As a courtesy to the public as well as to minimize security risks, all table holders are expected to keep their table(s) open for business during the designated hours that the Show is open to the public. Table holders closing their table(s) and/or leaving the Show during these hours (without the approval

of the Show Host) will forfeit preferred table locations at future Shows." Attendees pay to come to our Gun Show and it's disappointing when they find empty tables because vendors have left early. Unless there are extenuating circumstances, please be considerate of

our customers and abide by this rule.

The NMGCA is a 501(c)(3) non-profit organization and as such, we are charged with providing an educational element to the public. One way we accomplish this is through displays at Gun Shows. We encourage all to consider setting up displays at our shows to promote interest and education.

Tables for display are free and displays are judged for monetary awards. When completing the table application, indicate that you will be setting up a display. Rules and regulations for displays include the following: "No item may be sold, traded, or removed from a display during the show. Eligibility for competition requires a display to be set-up from 10: a.m. Saturday morning until 3:00 p.m. Sunday. A display may not be covered during the hours the show is open to the public."

In the past we have been privileged to have displayers who put much time, financial resources, and energy into providing a quality product. They take pride in their displays and work hard to make them the best they can. We invite you to join the ranks of these dedicated individuals and consider providing a display at our future shows. ment, personal integrity and patriotism.

To meet educational requirements at the Academy, cadets complete core curriculum, U.S. Naval Science courses, and physical training. The Academy supports all military services and is dedicated to educating and preparing cadets for civilian as well as military careers.
